Your letter of September 28, 2010 to Susan Ehrlich at Santa Barbara City College has been referred to this office for response. Please direct future correspondence regarding this matter to this office.

Your letter contains an enormous number of erroneous and misinformed allegations, and we will respond in detail within the next week. However, as you requested, we write to address the single issue of expressive activity during the candidates' forum that is scheduled on campus for Thursday, September 30. We have discussed the matter with the College President, and are authorized to assure you and your clients that persons wishing to engage in free speech activity outside the building where the forum is scheduled to occur will be permitted to do so. As required by the District's regulations, they may not disrupt foot or vehicular traffic or block the entrance to the building, but are otherwise free to communicate with persons coming to the forum and otherwise on campus. They can set up tables outside the building if they wish on the grass near the entrance.
